



*Minutes of the Annual General Meeting of the Municipal District of Piltown  
held Wednesday, 8<sup>th</sup> June, 2022 at 11.30am*

He thanked all the officials, S. Cullen and staff for their hard work and support throughout the year and thanked the press their attendance and excellent coverage at all times. He thanked his fellow elected members, who work very well together for the people of South Kilkenny and are very supportive of each other and he thanked them for their cooperation and efforts throughout the year.

**1. Election of Cathaoirleach**

**2. Election of Leas Cathaoirleach**

Cllr Dunphy nominated **Cllr Ger Frisby**; this was seconded by Cllr Aylward and agreed.
